

20 New Fields Recognized in Kansas

The **Kansas Geological Society's Nomenclature Committee**, in association with the **Kansas Corporation Commission (KCC)** and the **Kansas Geological Survey**, recognized and named 20 new oil and gas fields in Kansas at a meeting held on March 18, 2015 in Wichita, Kansas.

The total number of *new oil and gas fields* recognized in 2015 comes to 26, or six more discoveries that were completed in same period a year ago - a gain of 30 percent. There were no new "*infield wildcat*" discoveries in established fields in February, holding the total number of new discoveries of *all types* in Kansas this year to 27. This is four more discoveries (new and infield) compared to a year ago - a gain of nearly 17.4 percent. The Nomenclature Committee also extended the boundaries of several existing oil and gas fields, as well as, recognized new formation pay zone discoveries in ten established fields.
